#### H-2A:

Seasonal ag labor

Uncapped visa category

 Single filing can cover multiple named / unnamed workers



#### H-2B:

Seasonal non-ag labor  Capped visa category, with 2 visa groups available based on the first half and second half of the government's fiscal year

 Single filing can cover multiple named / unnamed workers





## Maximum period of stay

- 36 months maximum period of stay
- May depart U.S. for 3 months to receive an additional 36 months ("re-set")
  - If stay in U.S. for 18 months or less, 45 days abroad will be interruptive ("re-set")
  - If accumulated length of stay is more than 18 months, 2 months abroad will be interruptive ("re-set")





## Strategic use of H-2A / H-2B

- Employer defined by FEIN
  - But, DOL can review employer circumstances to confirm whether entities with separate FEINs function as a single employer
- H-2A and H-2B opportunities may support separate seasonal needs
  - Could employer partnerships cover 72 months of nonimmigrant work authorization?





**PERM** 

• 3-step process: **PERM**, I-140, I-485

- PERM DOL Platform Change (6/2023)
  - Prevailing wage determination
  - Recruitment
  - Online filing through DOL FLAG
  - Certification taking 12+ months
  - Filing established "priority date"



**IV** Petition

• 3-step process: PERM, **I-140**, I-485

- I-140 Immigrant Visa Petition
  - USCIS filing to confirm PERM, beneficiary qualifications, and employer ability to pay
  - USCIS government filing fee adjustment to \$715 (from \$700) – effective April 1, 2024



Adjustment of status

• 3-step process: PERM, I-140, **I-485** 

- I-485 Adjustment of Status Application
  - Personal application to change status (not employer sponsored)
  - Family members can simultaneously file, thereby qualifying for a work permit and travel document; USCIS now issues benefit for 60 months (fall 2023)
  - Requires an available visa number based on "priority date"

#### A. FINAL ACTION DATES FOR EMPLOYMENT-BASED PREFERENCE CASES

On the chart below, the listing of a date for any class indicates that the class is oversubscribed (see paragraph 1); "C" means current, i.e., numbers are authorized for issuance to all qualified applicants; and "U" means unauthorized, i.e., numbers are not authorized for issuance. (NOTE: Numbers are authorized for issuance only for applicants whose priority date is **earlier** than the final action date listed below.)

#### B. DATES FOR FILING OF EMPLOYMENT-BASED VISA APPLICATIONS

The chart below reflects dates for filing visa applications within a timeframe justifying immediate action in the application process. Applicants for immigrant visas who have a priority date <u>earlier than</u> the application date in the chart may assemble and submit required documents to the Department of State's National Visa Center, following receipt of notification from the National Visa Center containing detailed instructions. The application date for an oversubscribed category is the priority date of the first applicant who cannot submit documentation to the National Visa Center for an immigrant visa. If a category is designated "current," all applicants in the relevant category may file, regardless of priority date.

The "C" listing indicates that the category is current, and that applications may be filed regardless of the applicant's priority date. The listing of a date for any category indicates that only applicants with a priority date which is **earlier** than the listed date may file their application.

### Adjustment of Status Filing Charts from the Visa Bulletin

If USCIS determines there are more immigrant visas available for a fiscal year than there are known applicants for such visas, we will state on this page that you may use the **Dates for Filing** chart. Otherwise, we will indicate on this page that you must use the **Final Action Dates** chart to determine when you may file your adjustment of status application. However, if a particular immigrant visa category is "current" on the Final Action Dates chart or the cutoff date on the Final Action Dates chart is later than the date on the Dates for Filing chart, applicants in that immigrant visa category may file using the Final Action Dates chart during that month.

We anticipate designating one of the two charts each month and linking to the relevant chart below within one week of DOS's publication of the <u>Visa Bulletin</u>.

#### Current Month's Adjustment of Status Filing Charts

For Family-Sponsored Filings:

For all family-sponsored preference categories, you must use the <u>Dates for Filing chart in the Department of State Visa Bulletin for April 2024</u>.

For Employment-Based Preference Filings:

For all employment-based preference categories, you must use the <u>Final Action Dates chart in the Department of State Visa Bulletin for April 2024</u>.
